

ORDINANCE 2010-12

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCE'S OF THE BOROUGH OF BRADLEY BEACH, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, CHAPTER NINE, TRAFFIC, AMENDING SECTION 9-3.6 a.1(a) & (b) AND RESCINDING SECTIONS 9-3.6 a.5 & 9-3.10

WHEREAS the Mayor and Council of the Borough of Bradley Beach finds that there is a need to provide uniformity in its regulation of parking in municipal lots and;

WHEREAS the Mayor and Council of the Borough of Bradley Beach finds that there is a need to adjust the parking regulations controlling the municipal lot at and about Cliff and Ocean Avenues in the Borough of Bradley Beach and;

WHEREAS the Mayor and Council of the Borough of Bradley Beach finds that there is a need to control the use of the parking lot at and about the Borough Hall property to meet the needs of the Borough offices and the community;

BE IT ORDAINED by the Mayor and Council of the Borough of Bradley Beach that Chapter Nine, Section 9-3.6 a.1(a) & (b), of the Revised General Ordinances of the Borough of Bradley Beach shall be revised to read as follows:

9-3.6.a.1.(a) In reference to the municipal parking lot on the east side of Ocean Avenue from Cliff Avenue to the northerly boundary of the Borough of Bradley Beach.

(i) Except for times otherwise controlled by Section 335 of these ordinances, Parking Meters, it shall be unlawful and a violation of this chapter for any person to cause, allow, permit or suffer any vehicle of any kind or nature, registered in the name of, or operated by such person, or placed or driven thereon by any person, to park or stand anywhere in such parking area for a period in the excess of two hours at any one time between the hours of 9:00 a.m. and 5:00 p.m.

(ii) It shall be unlawful and a violation of this chapter for any person to park any vehicle in said parking lot between the hours of 10:00 p.m. and 5:00 a.m.

9-3.6.a.1.(b) In reference to the municipal parking lot on the north and west sides of Borough Hall

(i) Only "Authorized Vehicles," defined as those vehicles operated by individuals conducting Borough business or attending Community Center activities or Borough sanctioned activities, shall be permitted to park in the municipal lot between the hours of 5:00 a.m. and 5:00 p.m., Monday through Friday.

(ii) It shall be unlawful and violation of this chapter for any person to park any vehicle in said lot between the hours of 3:00 a.m. and 5:00 a.m. on any day of the week.

(iii) Police Vehicles, Borough vehicles and vehicles operated by Borough employees while at work or contractors performing work for the Borough shall be permitted to use the municipal parking lot at all times

BE IT FURTHER ORDAINED by the Mayor and Council of the Borough of Bradley Beach that Chapter 9, Section 9-3.6 (a)(5) shall be rescinded in its entirety; and

BE IT FURTHER ORDAINED by the Mayor and Council of the Borough of Bradley Beach that Chapter 9, Section 9-3.10 shall be rescinded in its entirety.
